## **Bellarine Community Safety Group - Quarterly Update**

Last month, we held our quarterly meeting of the Bellarine Community Safety Group (bSafe). The session focused on key local issues and how we can strengthen community communication—particularly through this newsletter.

A prominent topic was the growing popularity of e-scooters on the Bellarine. We discussed current regulations and want to remind everyone of the following rules to ensure safe and legal use:

- Riders must be at least 16 years old
- Speed is limited to 20km/h
- Helmets are mandatory
- E-scooters must not carry passengers
- They can only be used on shared-use paths or roads with speed limits of 60km/h or less
- E-scooters are not permitted on footpaths

Another key discussion point was the recent public transport announcements in the 2025/26 State Government Budget. From 1 January 2026, children and young people under 18 will be eligible for free travel on all public transport across Victoria—fantastic news for families and a big step in reducing travel costs.

This follows a recent commitment to provide free weekend public transport for Victorian Seniors Card holders, while continuing discounted travel during weekdays.

The budget also includes funding for a comprehensive review of the Bellarine Peninsula bus network. As part of this review, community members will have the opportunity to share their views on proposed improvements to routes, timetables, and overall service quality.

I'll keep you informed throughout this process and make sure everyone has a chance to get involved as we work toward a more connected and accessible Bellarine.

## E-scooter Road Rules

Tougher penalties as e-scooters are made permanent.



### e-scooter riders cannot

- Ride on the footpath
- Use a mobile phone while riding
- Ride while under the influence of drugs or alcohol
- Carry passengers or animals or ride in tandem
- Ride a high-speed e-scooter, one capable of more than 25 km/h
- Ride on roads that have a speed limit over 60 km/h



#### e-scooter riders must

- Be aged 16 years and over
- Not exceed the maximum speed of 20 km/h
- Ride only on shared paths and roads that have a speed limit up to 60 km/h
- Wear a helmet at all times
- Follow traffic rules
- Use lights and reflectors

# Machete ban

A machete is a broad-bladed cutting knife. Examples include but are not limited to the images below.



From September the 1st Victorians cannot own, use or sell a machete. Keep an eye on our newsletter for the upcoming machete amnesty. In the meantime if you wish to surrender a machete you can attend either the Portarlington or Bellarine Police Stations prior to the amnesty. The procedure is as follows: attend in person at the police station during open hours. Leave your machete in your car. Inform the police member that you have a machete to surrender before returning to your car to bring it in for surrender. # The Police Assistance Line 131 444

You can call the Police Assistance **131 444** to report some non-urgent crime and events anytime, anywhere.

Examples of non-urgent crimes and events include:

- burglary including at a commercial property or a home with no occupant present
- general theft (including theft of a motor vehicle)
- property damage
- lost property
- general enquiries.

Save **131 444** to your phone contacts to report non-urgent crimes in the future.

All calls to the Police Assistance Line are recorded and retained by Victoria Police. This is for training and policing purposes.

## When not to use the Police Assistance Line

The Police Assistance Line cannot assist you with urgent matters or emergencies, including:

- family violence
- assault
- shop theft or petrol drive-offs
- a crime that is happening now
- if you see something or someone suspicious

In these incidents where there is an emergency, contact <u>Triple</u> <u>Zero (000)</u>.

# NEIGHBOURHOOD WATCH LAUNCHES NEW VEHICLE SECURITY QUIZ TO COMBAT RISING THEFT

In response to growing concerns about vehicle theft and items being stolen from vehicles across Victoria, Neighbourhood Watch, supported by RACV, has launched: *How safe is my vehicle*?, an online quiz designed to help Victorian's protect their cars and belongings from theft.

The release of the new quiz is timely given new data released on 20 March, 2025, from the <u>Victorian Crime Statistics Agency</u> has revealed theft of motor vehicles has increased by almost 8,432 in the last 12 months, up 41.5 per cent. Theft from a motor vehicle also increased by almost 19,000 in the last 12 months, up 33.32 per cent. Both figures represent a ten year high.

The free *How safe is my vehicle* quiz provides practical advice, security recommendations, and step-by-step guidance for vehicle owners to protect their vehicle, including caravans.

Neighbourhood Watch CEO Bambi Gordon said every Victorian should feel confident about their vehicle's security.

"The *How safe is my vehicle* quiz puts practical prevention tools directly into the hands of vehicle owners, empowering them to take proactive steps to protect their vehicle," Ms Gordon said.

"This initiative comes at a crucial time as vehicle-related crime continues to impact Victorian communities."

The report generated from the quiz, includes:

- Information about the latest anti-theft technologies
- · Best practices for secure parking
- Practical tips to prevent theft from vehicles.

"We've created a valuable resource that addresses a pressing community need aimed at making Victorian communities safer," Ms Gordon said.

The initiative is supported by local Neighbourhood Watch volunteer groups who will help raise awareness and provide hands-on guidance to community members.
